

TEL Programme update



Simulation Based-Education

The project delivery team for the Simulation Based-Education (SBE) Strategy is extremely pleased to note that local office simulation leads have been working to complete the responses to the SBE Framework KPIs since their issue in November 2018. This is a measure of how well everyone is engaged with the SBE Strategy, emphasising the sense of sharing and collaboration.



A virtual meeting with the regional TEL Leads has been arranged to review the rag ratings, looking at consistency in how these ratings were applied. A report can then be prepared and shared with members of the SBE Assurance and Development Committee, chaired by Professor Bryn Baxendale, in March. The project delivery group will then begin to develop more detailed KPIs, based on the responses.

The outputs from the task and finish groups are developing well and the guidance for faculty

development is close to completion. The last meeting to review this document is scheduled for February. Other pieces of guidance due for development and release over the coming months include;

- leadership and governance
- resource allocation (Learning and Development Agreement LDA guidance)
- quality outcomes (In-situ framework and 'what makes a good sim network' and a
- quality assurance template.



Some of the TEL Programme recently visited the Simulation Centre at University Hospitals of North Midlands NHS Trust and the Medical Defences Services in Lichfield, both of which provided a great insight into the exciting developmental work that is going on within the simulation world.

Further SBE News

8th Homerton Simulation Conference



In December 2018, 110 people attended the Homerton Simulation Conference, which included faculty, exhibitors and speakers. The focus this year was on how virtual reality can be used to improve healthcare education. A challenging keynote from Captain Niall Downey FRCSI, Flight Captain for Aer Lingus, encouraged the simulation community to redouble their efforts to reduce death and injury rates from error in healthcare by continuing to develop a 'Just Culture', safer systems and more human factors skills training. Several VR solutions were showcased for CPR training (Dual Good Health), surgical skills training (Fundamental VR) and clinical decision making (Oxford Medical Simulation).

As at the ASPiH conference in November last year, it was emphasised that it's not a case of 'out with the old' and workshop discussions of excellent inter-professional simulation programmes in allied health, obstetrics and neonatal care were well received. In addition, Newcomb Library Manager, Kaye Bagshaw, also shared 'old school' offers in practice at

Develop your digital capabilities with our Al-powered tool

Do you know what your digital learning needs are? We have developed a self-assessment tool that provides personalised and unique recommendations based on your learning needs.

Our personalised learning tool uses resources and information from the HEE Digital Capabilities framework and has been developed with Artificial Intelligence pioneers Filtered. For example, there are short learning resources to quickly help you improve a specific skill and longer resources to help you develop and enhance your wider skills and capabilities.

We would like to give you the opportunity to test the Alpha prototype of this tool yourself and with your networks across the NHS. We would be grateful if you could please cascade this to your health and care colleagues and networks. The tool is anonymous, and data won't be shared with your organisation.

<u>How it works</u>: You answer a few simple questions presented to you by our chatbot called Magpie. Magpie then analyses your answers and presents you with learning resources that it thinks are relevant to your needs.



It's a little like Spotify or Netflix that learn your tastes, preferences and needs. The more

you use it, the better it will become for you and for other users of the tool.

Update on the Learning Solution

The development of the Learning Solution is progressing at pace with the design team currently working on pulling some of the high-level concepts for the Learning Solution into prototype home and search pages. These prototype screens are being presented to the Chair of the Clinical Expert Advisory Group (CEAG) and the TEL programme clinical lead for initial feedback before participation and engagement is broadened to all key user research and stakeholder groups.

TEL vision

TEL national and regional colleagues came together in December 2018 for a workshop to discuss a shared TEL vision.

The workshop gave colleagues from the national team and from regional teams across the country an opportunity to discuss their thoughts and views on the development of a shared TEL vision.

The team spent an engaging session taking part in activities, which sought to find a shared vision from existing individual visions, by finding common themes and similar goals. We spent the first part of the workshop discussing our TEL related successes and strengths followed by future successes that we thought TEL may bring about. In the final session of the workshop we each wrote three individual visions for our preferred future relating to TEL. We shared these with the rest of the group and common themes and goals were identified, beginning to form the basis of our shared vision. The workshop was a very positive and engaging step towards developing a TEL vision. A task and finish group will be established to agree the next steps and bring that vision to life.

Learning paths

Foundation e-Learning Programme update:



e-LfH Foundation e-Learning Programme: Professional Capability: 1 Acts professionally and Professional Capability: 2 Delivers patient centred care and maintains trust

Developed by the Academy of Medical Royal Colleges in partnership with HEE e-LfH and approved by UKFPO – Foundation is a free e-learning programme for Foundation doctors.

Do you need to complete parts of the curriculum on your e-portfolio which you do not cover in day-to-day practice? If so, try some of our free e-learning mapped directly to the Foundation Professional Capabilities (Training Outcomes) in the 2016 Foundation Curriculum.

The e-learning sessions in these Professional Capabilities explore the relationship between doctors and their patients and how to deliver effective patient centered care.

'Handling Complaints' provides essential information about common factors leading to complaints, how to minimise these, the procedures involved and what your responsibilities are as a foundation doctor.

The Mental Capacity Act (MCA) protects the right of vulnerable people and this group of sessions cover topics such as assessing capacity, consent, patient autonomy and safeguarding. You will also consider the multidisciplinary team (MDT) approach to healthcare in the hospital and patient support after discharge.

Making Every Contact Count e-learning programme updates now live

HEE e-LfH has worked with Public Health England (PHE) and University of Brighton to update its Making Every Contact Count (MECC) e-learning programme.

This resource, comprising four e-learning sessions, is intended for anyone who has contact with people to "Make Every Contact Count" and develop public health knowledge. Based on feedback from learners, each of the four sessions have been reviewed and now benefit from revised and additional content with a focus on mental health. The template of the programme has also been updated.



In addition to the updated content, the MECC e-learning programme has now received accreditation from The University of Brighton. The MECC e-learning programme is already accredited by the Royal Society for Public Health (RSPH).

Dr Charlotte Ramage and Marianne Willmer from University of Brighton, said: "It has been a positive experience working with the PHE and HEE team. They have been inclusive and responsive to ideas throughout in the development of the online MECC programme. The e-learning public health initiative has been carefully constructed to appeal to its widest possible audience. By broadening accessibility, we hope the end users feel confident to discuss the health of colleagues in their team and the general public and embrace the health messages for their own health and wellbeing."

MECC is an approach to behaviour change that utilises the millions of day-to-day interactions that organisations and people have with other people to support them in making positive changes to their physical and mental health and wellbeing.

MECC enables the opportunistic delivery of consistent and concise healthy lifestyle information and enables individuals to engage in conversations about their health at scale across organisations and populations. Drawing on behaviour change evidence, the approach maximises the opportunity within routine health and care interactions for a brief or very brief discussion on health and wellbeing factors.

A MECC interaction takes a matter of minutes and is not intended to add to the busy workloads of healthcare professionals and the wider workforce, rather it is structured to fit into and complement existing professional clinical, care and social engagement approaches. The wider MECC e-learning programme is designed to support learners in developing an understanding of public health and the factors that impact on a person's health and wellbeing, emphasising how asking questions and listening effectively to people is a vital role for us all.

Managing Frequent Attenders

Using reflective practice to help patients who are frequent attenders



HEE e-LfH has worked with the Tavistock and Portman NHS Foundation Trust, the Royal College of Psychiatrists and Royal College of General Practitioners to produce a resource on managing frequent A&E attenders.

The bite-sized course takes around 20 minutes to complete and will equip learners with the knowledge to apply reflective practice in their day-to-day work with patients. It seeks to empower A&E staff to focus on what they do best; treating patients and saving lives.

Care Certificate e-learning programme updates



HEE e-LfH has updated the Care Certificate e-learning programme to add assessments to its knowledge-based sessions to help students and their assessors to review their learning on completion of the theory. The assessment pass mark is 80% and a certificate is available for learners to download on completion of each Standard.

If you are part way through completing the Care Certificate Standards, please be aware that the previous version of the

programme will remain accessible within an archive folder until 31 March 2019; enabling users and local administrators to access historic certificates and report on learning history.

For those organisations currently using our AICC functionality to launch the sessions on their own Learning Management System, please note that the existing separate session links will remain active. New links to the updated programme content are now available.

The updates to the Care Certificate programme will be available via ESR by the end of January 2019.

HEE kick-started the new year with the first of two workshops to co-produce learning designs for levels 3 and 4 adult safeguarding training. Designated adult safeguarding leads from Clinical Commissioning Groups (CCGs) and provider Trusts joined us from across the country to take part in a series of intensive, hands-on exercises. Participants developed a better understanding of the target audience for level 3 and created a set of storyboards with learner activities

aligned to the learning outcomes in the UK-wide Intercollegiate Document 'Safeguarding for Adults: Roles and Competencies'.
